- 2. (U) PURPOSE. TO ANNOUNCE CHANGE OF APPROVAL AUTHORITY FOR TRAVEL RELATED COSTS PURSUANT TO REFERENCES 1.A. AND 1.B.
- 3. (U) POLICY. PURSUANT TO REFERENCES 1.A. AND 1.B., REFERENCE 1.C. WAS SUPERSEDED IN PART BY REFERENCE 1.D. TO ALLOW APPOINTED ORDER ISSUING OFFICIALS APPROVAL AUTHORITY FOR ACTUAL EXPENSE ALLOWANCE, WHICH IS A FORM OF REIMBURSEMENT THAT, IN UNUSUAL CIRCUMSTANCES, ENABLES A TEMPORARY DUTY TRAVELER TO BE REIMBURSED FOR ACTUAL AND NECESSARY EXPENSES THAT EXCEED THE MAXIMUM LOCALITY RATE, UP TO A MAXIMUM OF 300 PERCENT OF THE LOCALITY PER DIEM RATE. ACTUAL EXPENSE ALLOWANCE REQUESTS NO LONGER REQUIRE APPROVAL ONE ORGANIZATIONAL LEVEL HIGHER THAN THE REQUESTER AND, UNLESS OTHERWISE APPOINTED, THE ADMINISTRATIVE ASSISTANT TO THE SECRETARY OF THE ARMY WILL NO LONGER SERVE AS THE APPROVAL AUTHORITY FOR ACTUAL EXPENSE ALLOWANCE OF 1–300 PERCENT OVER PER DIEM FOR TRAVEL BY HEADQUARTERS, DEPARTMENT OF THE ARMY PERSONNEL.
