2. (U) THE PURPOSE OF THIS MESSAGE IS TO ANNOUNCE FORTHCOMING REVISIONS OF AR 670-1 AND DA PAM 670-1 REGARDING THE WEAR AND APPEARANCE OF THE ARMY SERVICE UNIFORM.

3. (U) THE REVISED EDITION OF DA PAM 670-1 WILL ADD PLAIN BROADCLOTH AND POPLIN TO THE MATERIALS USED FOR THE OPTIONAL COMMERCIAL OFF-THE-SHELF SHIRT FOR MEN AND WOMEN.

4. (U) THE OPTIONAL SHIRT FOR MEN IS LONG-SLEEVED WITH BARREL CUFFS AND A STANDARD TURNDOWN COLLAR WITH TAPERED POINTS APPROXIMATELY 2-5/8 INCHES LONG IN BRIGHT WHITE OR ARMY WHITE 521.

5. (U) THE OPTIONAL TUCK-IN OVERBLOUSE FOR WOMEN IS PLAIN COTTON BROADCLOTH OR POPLIN IN BRIGHT WHITE OR SHADE ARMY WHITE 521.

6. (U) THE REVISION WILL STILL ALLOW WEAR OF ISSUED OR COMMERCIALLY PURCHASED HERRINGBONE WEAVE SHIRTS, PROVIDED THEY ARE WORN IN ACCORDANCE WITH THE SPECIFIC INSTRUCTIONS LISTED ABOVE AND IN DA PAM 670-1.
