- 3. (U) APPLICABILITY. THIS ALARACT APPLIES TO REGULAR ARMY SOLDIERS AND ARMY NATIONAL GUARD (ARNG)/ARNG UNITED STATES OR UNITED STATES ARMY RESERVE (USAR) SOLDIERS SERVING ON ACTIVE DUTY FOR OPERATIONAL SUPPORT.
- 4. (U) REFERENCE 1.D. AUTHORIZED SOLDIERS TO ACCUMULATE LEAVE IN EXCESS OF 60 DAYS THROUGH 30 SEPTEMBER 2023; HOWEVER, REFERENCE 1.E. EXTENDED THE SLA PROTECTED LEAVE AUTHORITY TO 30 SEPTEMBER 2024.
