THE ANNUAL AWARD IS INTENDED TO INCREASE PA MOTIVATION FOR EXCEPTIONAL JOB PERFORMANCE. THE AWARD PROGRAM APPLIES TO ALL ARMY COMMANDS AND ORGANIZATIONS HAVING ACTIVE DUTY PAS ASSIGNED ON A FULL-TIME BASIS IN CALENDAR YEAR (CY) 2023 (ACTIVE COMPONENT AND ACTIVATED RESERVE COMPONENT PAS WHO SERVED IN A DEPLOYED OR ACTIVE DUTY OPERATIONAL SUPPORT STATUS IN CY 2023. ARMY NATIONAL GUARD COMPONENT PAS ARE INELIGIBLE FOR THE AWARD).
- 3. (U) MISSION. NO LATER THAN 26 APRIL 2024, UNITS HAVING PAS ASSIGNED ON A FULL-TIME BASIS WILL NOMINATE ARMY ACTIVE DUTY AND RESERVE COMPONENT PAS FOR TSG-PARA FOR CY 2023. THE 20TH ARMY MEDICAL SPECIALIST (SP) CORPS CHIEF WILL CONVENE A SELECTION BOARD OF SENIOR SP CORPS PAS WHO WILL MAKE AN ORDER OF MERIT LIST (OML) RECOMMENDATION FROM 06–17 MAY 2024. THE SP CORPS CHIEF WILL SEND AN ENDORSED SELECTEE'S NAME AND THE OML TO THE SURGEON GENERAL FOR DECISION/APPROVAL NO LATER THAN 3 JUNE 2024.

- 4.B.1. (U) TSG IS THE AWARDING AUTHORITY.
- 4.B.2. (U) COMMANDERS AT ALL LEVELS WILL IDENTIFY POTENTIAL RECIPIENTS AND SUBMIT NOMINATIONS ACCORDINGLY. STAFF SURGEONS AT ALL MAJOR AND LOWER NON-MEDICAL COMMAND HEADQUARTERS WILL ASSIST COMMANDERS IN THIS REGARD. WITH CONCURRENCE OF THESE COMMANDERS, NOMINATIONS MAY BE SUBMITTED BY STAFF SURGEONS. COMMANDERS WILL PUBLICIZE THE AWARD AND ITS RECIPIENT WHEN ANNOUNCED, EMPHASIZING DUTY PERFORMANCE AND CONTRIBUTION TO MILITARY MEDICINE (WITHIN SECURITY AND PRIVACY ACT REQUIREMENTS).
