I. SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded posthumously to:

Technical Sergeant *William D. McClintock*, , United States Army, for action on 6 June 1944, while a member of Company A, 741st Tank Battalion, 2d Infantry Division. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

II. SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:
