**ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 21ST INFANTRY  
REGIMENT UNDER THE US ARMY REGIMENTAL SYSTEM (USARS)**

1. The 21st Infantry regiment is WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the US Army Regimental System, effective 16 January 1986. The 1st Bn, UIC: WAQFAA remains ASSIGNED to the 25th Infantry Division in Hawaii and the 5th Bn, UIC: WFK4AA remains ASSIGNED to the 7th Infantry Division at Ford Ord, CA.
2. INACTIVATE the 1st Bn, 5th Infantry, UIC: WALPAA under MTOE 7-15JP125, P18786 in Hawaii, effective 16 January 1986. The 3d Bn, 21st Infantry, UIC: WFBVAA will be ACTIVATED and ASSIGNED to the 25th Infantry Division in Hawaii, under MTOE 7-15JP125, P18786 with the following strengths: STSTR: 34 OFF, 1 WO, 506 ENL, 541 AGG-AUSTR: 34 OFF, 1 WO, 506 ENL, 541 AGG, effective 16 January 1986.
3. INACTIVATE the 3d Bn, 32d Infantry, UIC: WALFAA under MTOE 7-15JFC07, FC2086 at Ford Ord, CA, effective 16 January 1986. The 4th Bn, 21st Infantry, UIC: WFK3AA will be ACTIVATED and ASSIGNED to the 7th Infantry Division at Ford Ord, CA under MTOE 7-15JFC07, FC2086 with the following strengths: STSTR: 34 OFF, 1 WO, 535 ENL, 570 AGG-AUSTR: 34 OFF, 1 WO, 535 ENL, 570 AGG, effective 16 January 1986.
4. The 2d Bn, 21st Infantry remains assigned to the 24th Infantry Division at Fort Stewart, GA. The Bn will be inactivated and replaced by an element of another USARS regiment at a date to be determined.
